

Churches unite to defend Newry Cathedral - Newry Democrat report

Newry's Catholic, Anglican and Methodist church leaders have joined together to defend the city's cathedral, Peter Bayne reports in the Newry Democrat, Monday June 17.



Newry Cathedral Parish Administrator Canon Francis Brown (Centre above), Church of Ireland Rector Canon Scott McDonald and Rev Louise Donald of the Methodist Churches of Newry, Bessbrook and Warrenpoint are united in their concern over council plans to overshadow the Gothic granite grandeur of Newry Cathedral with a vast concrete office block known as the 'Civic and Regional Hub',

The city cathedral was the first opened in Ireland after Catholic emancipation. The building was constructed in 1829 – just as most restrictions were lifted from Roman Catholics across the UK and Ireland. The Catholic diocese dates back to the sixth century.

Believing their listed place of worship to be under threat, more than 2,500 Catholic parishioners have signed letters of protest objecting to the council offices. Their complaints were presented recently to the planning department of Newry, Mourne and Down District Council.

Canon Francis Brown – who has just celebrated the 50th anniversary of his ordination – feels the Council should listen to the community and put a halt to this 'expensive, unpopular and unnecessary project' that parishioners feel will eclipse the Cathedral's bicentenary celebrations in 2029. 'Newry people are asking the Council not to blight its appearance with a wholly inappropriate modern building,' he said. 'Surely this is not too much to ask?'

Canon Scott McDonald – who is Rector of St Patrick's and St Mary's, Newry – said, 'I fully support Canon Brown and his parishioners as they seek to protect the environment around the Cathedral. I would hope that their entirely legitimate concerns are not just noted – but also addressed respectfully and diligently. As a faith community they must be heard seriously and their protests upheld'.

Revd Louise Donald said, 'The congregations who form the Newry Circuit of the Methodist Church in Ireland would urge Newry, Mourne and Down District Council to give serious consideration to all options in relation to the siting of the new Civic Hub – and in particular to give due deliberation to the concerns raised by parishioners of Newry Cathedral.

'The impact of any new construction on the buildings which surround it must be adequately assessed, but surely particular regard must be given to a structure with the historic and aesthetic significance of the Cathedral. There should also be attention given to any potential constraint on the life of the worshipping community of the Cathedral, which has been present there for almost 200 years.'

Bishop Andrew said he and the Dean enjoyed their visit to Etta's home immensely. "We had a fascinating conversation about her life growing up in the city, and her memories of life here during the Second World War. It was lovely to be with her and her three children at her home."

Independent review of Winchester Cathedral music department

The Bishop of Winchester has commissioned an independent review of Winchester Cathedral, it was announced late on Tuesday.

The review comes after weeks of allegations about the conduct of the cathedral's music department, and the resignation of the senior non-executive member of Winchester Cathedral Chapter, Mark Byford, a former head of the BBC World Service and its former deputy director-general.

A brief statement by the Bishop, the Rt Revd Philip Mounstephen, refers to this resignation, saying: "In the light of that significant development in the cathedral's governance, the Bishop has decided to commission an independent review, under the terms of the Cathedral's Measure 2021, into the events that have led to this."

The Dean of Winchester, the Very Revd Catherine Ogle, said this week that the cathedral's music was "fundamental to our worship".

Last week, Winchester Cathedral appointed an interim director of music, Andrew Lucas, from St Albans Cathedral, to succeed Dr Andrew Lumsden, whose unexpected resignation on 2 May triggered allegations about the management of the cathedral's music department. A call for an independent review of the department came from Toshi Ogita, a chorister and professional singer who deputises for the lay clerks of Winchester Cathedral Choir. Last week, he wrote to Bishop Mounstephen, as questions around the circumstances of Mr Lumsden's departure and the behaviour of the Precentor, Canon Andy Trenier, continued to surface on choral social-media sites and in sections of the press.

Belfast Telegraph - Case of parish minister accused of £10,000 theft is about 'downright dishonesty', court told

A parish minister has gone on trial accused of abusing his position to steal over £10,000 from both his church and a hospital grouping, Paul Higgins reports in the Belfast Telegraph. June 19 2024 3:55 PM

Opening the trial concerning 50-year-old Reverend Adrian McLaughlin, Crown counsel Joseph Murphy told the jury today that according to the prosecution "this case is not about bad bookkeeping — this case, we say, is about downright dishonesty".

He told the Craigavon Crown Court jury while they were duty-bound to consider each of the six counts separately, "we say there's a certain overlap between the counts, there is a central theme."

"That theme is that the defendant abused his position as rector in order to serve his own personal interests," declared Mr Murphy.

Rev McLaughlin, with an address at Church Avenue in Dunmurry, faces a total of six charges of committing fraud by abuse of position on dates between October 15, 2016, and October 1, 2018, with five of the offences relating to St Coleman's Parish Church and the final charge relating to his role as a "constructive trustee" with the Royal Victoria Hospital (RVH) Liver Unit Group.

The particulars of the offences accuse Rev McLaughlin of writing out a \pounds 10,000 cheque to himself; taking a \pounds 1,000 donation for himself, taking \pounds 520 from two complainants who had made donations and one who paid to use the church hall.

They also include an accusation that Rev McLaughlin pocketed donations from a funeral held at the church but intended to go to RVH Liver Unit Group at a time when he was a "constructive trustee of the said monies for the benefit of the RVH Liver Unit Group".

Emphasising that his opening was not evidence in the case, Mr Murphy told the jury how Rev McLaughlin was appointed as the rector of Dunmurry Parish Church in June 2014 and he, along with his then-wife Christine, lived in the rectory.

In January 2016, "the church building suffered significant damage in a fire" and the jury heard that in the aftermath, "much of the governance" of the parish and its rebuild was down to the rector and the "select vestry" but with no Church News Ireland Page 19

treasurer in place for a few months from August 2016, cheques had to have two signatures.

Taking each charge in turn, Mr Murphy said the first count related to what he termed as the "organ cheque" and told the jury that according to the Crown case, Rev McLaughlin asked John Williams, a member of the select vestry, to sign a cheque for £10,000 claiming that it was to buy a replacement organ from a church in Glasgow.

The defendant allegedly told Mr Williams "he needed to pay for it soon or they would miss this great bargain" and although the payee line was blank, "the defendant told him he needed to get the correct name of the organisation" and when he got that "he would write it in himself."

"Mr Williams, trusting the rector of his church, co-signed that cheque," said Mr Murphy adding however that the cheque "did not get to any organisation selling an organ — it was lodged into the defendant's own personal bank account six days later."

As the cheque stub had been filled out that the payee was NI Organs Ltd, the "irregularity went unnoticed" for some time but by November 2018, "some of the parishioners complained to police about financial irregularities involving the defendant."

When the reverend was asked by police about the £10,000 cheque, he admitted lodging it into his own account but initially claimed "he had permission of the select vestry to do so" with £4,000 of it for expenses he had personally incurred and the remainder for "future church expenses."

Later on, however, Rev McLaughlin's "account changed" and he claimed that instead of that being agreed at a formal meeting where there would have been minutes taken, he claimed there had been an informal agreement with Mr Williams and his wife Lynn who would become church treasurer.

Count two, he told the court, related to a cheque for £1,000 written out by a lady whose husband had sadly died and she wanted to make a donation.

She left the payee line blank but handed the cheque to the defendant "making it clear that this was a donation to the church in memory of her late husband" but subsequent enquiries revealed that the cheque "was lodged not into the church bank account but into the rector's personal account on 17 October 2016, the day after Mr Williams co-signed the £10,000 cheque."

During police interviews, Rev McLaughlin claimed he had used £800 of it to buy two antique candlesticks from a shop in Saintfield and that he remembered lifting £800 from an ATM to pay for them and that his wife was there.

Police investigations however showed there had been no such withdrawal from his account and also that "his ex-wife has no memory of that ever happening".

Count three related to a slimming world group paying £120 every week, in cash, to Rev McLaughlin but according to the Crown case, none of that money was ever lodged into the church's bank account. **Church News Ireland**

The new treasurer asked the defendant where the cash was or for the receipts but he told her "he had been using it as petty cash to discharge expenses."

The last three counts related to payments for funerals being conducted and also a collection taken at one of them, money which the Crown say was never properly lodged but instead was taken by the defendant.

Explaining that it is for the jury to decide what evidence they accept and what they reject, Mr Murphy told the jury they may feel sympathy for the congregation of Dunmurry Parish Church who "placed blind faith in their rector" and found that faith was abused or they may feel sympathy for Rev McLaughlin that as a man of God "his reputation is on the line."

He told them however they must approach the trial, set to last until the end of next week, "coolly, calmly and dispassionately" and when they do, "we will ask you to return verdicts of guilty."

The trial continues.
