# Ashers Bakery discrimination appeal halted

A high profile appeal by Christian bakers who were found to have discriminated against a gay customer has been dramatically halted to

facilitate an intervention by the north's top legal adviser.

Irish News - Attorney General John Larkin QC has made a last-minute request to make representation in the case about any potential conflict between the region's equality legislation and European human rights laws.

The McArthur family's refusal to bake the customer's order for a cake bearing a pro-gay marriage slogan was ruled unlawful last year.

Lord Chief Justice Sir Declan Morgan said: "It is most unfortunate this issue has arisen only two days before this hearing.

"Although we have all tried to see if we could proceed with the case given the amount of work that has been done.

"It seems to us that it is simply not possible to do that without running into some risk of fairness in the hearing.

"We are not going to proceed with the hearing today."

Gay rights activist Gareth Lee, a member of LGBT advocacy group Queer Space, had wanted a cake featuring Sesame Street puppets

### Derry parish's weekend celebration in renewed centre

This weekend, the Christ Church, Culmore, Muff and St. Peter's (CCCMSP) Group of Parishes will gather to celebrate and give thanks for the recent refurbishment of their Parish Centre, on the Culmore Road.

Over the past nine months, more than £100,000 has been raised to finance the work, which brings the centre up to the necessary health and safety standards. Among the improvements are a new kitchen, toilets, heating system and internal doors, and new flooring has been laid throughout. The building has also been painted inside and out, and new insulation fitted.

The money for the refurbishment was raised through donations from parishioners and groups who already use the centre, and with funding from the Garfield Weston Foundation and Awards for All.

The public are invited to visit the Parish Centre this Saturday, 6th February, between 2.30pm and 5.30pm, to see the improvements. Existing user

groups will be putting on demonstrations and providing information for people who wish to enquire about classes. Refreshments will be served throughout, and the afternoon will finish with a Service of Celebration and Dedication at 5pm.

A number of local groups already use the centre weekly, including Zumba, Weight Watchers, Irish Dancing, Baby Sensory and a Quilting Class. It is also used by the parish badminton group, bowls group, Sunday School and Mothers' Union. Throughout the year, other groups use the centre for fundraisers, meals, parties and youth events. They include Mencap, the City of Derry & District Gardening Society, Marie Curie Cancer Care, Limavady Grammar School, Badgers and the Church of Ireland. The Parish Centre can be hired for weekly classes or one—off events.

Padre Donald was responsible for taking Sunday morning services at St Columba's Church in the

UN Protected Area, Nicosia, in his wider role as Padre for all soldiers that make up the British Contingent in UNIFCYP.

Padre Donald presented Padre Bell with a R IRISH plaque to mark the service of what is now forty 2 R IRISH soldiers on Op TOSCA 23. The plaque will be displayed at St Columba's Church alongside those of the Royal Ulster Rifles and Royal Irish Rangers, presented by the antecedent Regiments during their time in Cyprus in the 1950's and 1970's.

## Creative approach to Lent at Christ Church, Dublin

Christ Church Cathedral, Dublin, will be hosting a creative project entitled 'Give Us Grace' during Lent 2016. Beginning on Ash Wednesday, February 10, the project will be exploring the Lenten themes of journey, temptation, challenge and reliance on God's grace through a variety of creative activities and experiential prayer.

Throughout the day on Ash Wednesday, a team of designers led by locally based artist Laura Petit will be preparing a large labyrinth on canvas in one of the cathedral's side chapels. Visitors to the cathedral that day will be invited



to participate in the project as well, and with the direction of the artists will have the opportunity to join in the painting, concluding their work just before the Ash Wednesday service that evening at 6.00 pm. Once the labyrinth creation has fully dried, it will remain installed in the cathedral until Easter for any who would like to walk the labyrinth as an aid to prayer.

Tuesday evenings in Lent will feature 'Cathedral Nights', during which the cathedral will be open from 7.00 until 9.30 pm. In this time there will be space for individual prayer, walking the labyrinth, a quiet cup or tea or coffee and also a variety of directed, reflective activities including:

When in the desert, what do you encounter? What are your temptations, the things that bind you? What voices do you here in the wind?

### C of I dean at reunion of 1965 Queen's expedition to Morocco

In 1965 nine Queen's students – Stanley Bell, John Clarke, Nick Crichton, John Hall, Dick Scott Kerr, Robin Martin, Roy McClelland, Philip Reilly and Ivan Robinson – and John Dinnen, a C of I divinity student from Trinity College Dublin, took part in a 10-week trek to South Morocco.

Funding was, in part, provided by the World Health Organisation and the Medical Research Council, in return for which the team investigated options for immunisation programmes amongst the nomadic tribes in the region, and carried out physiological and psychological tests on themselves.

The group comprised of four geographers, two medics, two linguists, a mechanic and a photographer and together they carried out a study of the effects of dehydration on body



functions. The associated psychological tests were undertaken on behalf of the Medical Research Council (London).

Studies were also made of the comparative life styles of the Arab desert nomadic tribesmen, with that of the sedentary people living in the oases and villages, skirting the edges of North West Sahara, many of whom had forsaken the harsh nomadic existence.

The journey took them over the Pyrenees, the Sierra Nevada Mountains of southern Andalusia and the Atlas Mountains which was in contrast to the time spend in the desert environment.

The 50<sup>th</sup> reunion in September 2015 started in the Senate Room where the eight members who attended watched film coverage of the trip, this being the first time the majority of them had seen it. Two expedition members travelled from Canada and three from England. The two who were unable to attend sent their best wishes.

That evening, there was much reminiscing, storytelling, leg-pulling and singing over a special meal in local restaurant, Deanes at Queen's.

"Throughout the day the recollections of the team's combined memories of the numerous incidents and events, which occurred during our ten weeks trip brought home just how remarkable and how unique an experience it was for us all," said organiser, Stanley Bell.

On what was a beautiful Belfast evening, the former 'desert rats' and their wives were happy to pose for photographs on the quad lawn, opposite the former Geography Department from where they had left in two long wheel-base Land Rovers on their epic journey 50 years earlier.

### Black Santa funding will benefit more than 220 charities

More than 220 charities will this weekend benefit from money raised during the 2015 Black Santa Sit-out on the steps of St Anne's Cathedral.

The 39th annual Sit-out raised £195,000 and at the annual Good Samaritans Service on Sunday February 7, well-loved local comedians May McFettridge, Jimmy Cricket and William Caulfield will give up their time to present cheques to charities and community groups who strive to make life better for others.

This was Dean John Mann's fifth Christmas Sitout as he maintains a tradition established by the late Dean Sammy Crooks almost 40 years ago.

The Good Samaritans Service takes place on the first Sunday in February each year, which the Dean said was "always a happy day in St Anne's Cathedral."

Smiles are definitely guaranteed this year with the line-up of special guests!

Dean Mann said: "More than 200 charities will benefit, representing a huge amount of voluntary and community work. This must be one of the most comprehensive gatherings anywhere in Northern Ireland of a spectrum of charitable work taking place, from organisations aiding young people to those supporting the elderly, from those struggling with medical conditions to those working in reconciliation and healing in its broadest sense. They include many cross—community initiatives and those working in places of social deprivation.

"It is a celebration of much that is good and praiseworthy in our community, and an opportunity to thank those who turn money into action and goodwill into improving the lives of others. It is a privilege to be part of it."

## Chancellor's tax reform plan must start now says Christian Aid

.George Osborne's announcement that multinationals should have to publish currently secret information about their global affairs could hail a tremendous breakthrough in the war against tax dodging, Christian Aid said this week.

"We are excited to see that the Chancellor has accepted the need for multinationals to go public about the business they do, and the taxes they pay, wherever in the world they operate,"

said Joseph Stead, Christian Aid's Senior Adviser on Economic Justice.

"What is vital now is that Mr Osborne follows up his good words with immediate action.

"With the UK and scores of other countries, including the poorest, haemorrhaging billions every year as a result of the irresponsible tax practices of multinationals such as Google, we cannot afford any delay. Rapid action is the only way to rebuild the public trust in our companies and our government."

Christian Aid believes the Chancellor could begin by introducing the reform very rapidly within the UK – this is something that is within the power of the UK Government and should be possible within a matter of months.

The reform in question is public country-bycountry reporting, which in the wake of the Google tax row Mr Osborne has said he favours. It would see multinationals publicly revealing details such as their taxes paid, profits made, staff employed and assets owned, separately for every country in which they operate.

Such information is hugely powerful because it will help to highlight which multinationals are shifting their profits into tax havens in order to avoid or even evade taxes in the countries where they are due.

This in turn will generate public demand for governments to act against companies seen as abusive – and give companies an incentive to clean up their own acts. Country-by-country reports will also highlight responsible behaviour by companies that are already contributing their fair share of tax in all jurisdictions where they operate.

The UK Government is currently drafting regulations requiring multinationals to provide country-country reports to HMRC and it would be simple to make the reports public at the same time.

Polling shows that the UK public are overwhelmingly in favour of increased transparency, while a recent survey of FTSE 100 companies by Christian Aid showed that the majority would accept such a move.

Mr Stead added: "At the same time as introducing the reform within the UK, the Chancellor should push for its adoption across Europe and by OECD and G20 countries. If the UK takes the lead, then there is little doubt that other countries will follow. There is already a proposal on the table from the European Parliament that the UK could support immediately.

"Finally, Mr Osborne, should ensure that there is absolute clarity about what information multinationals have to make public. The OECD has already developed a template for country-by-country reporting to tax authorities – and this should be the basis for all public reporting.

"The OECD template contains most of the information we want to see, and using this standard would reduce compliance costs for businesses".

Christian Aid has campaigned for public country-bycountry reporting since 2008 because the reform would help developing countries and others to catch up with multinational tax dodgers and provide information to help improve the design and effectiveness of tax rules.

All the main UK political parties have supported public country-by-country reporting. The Conservative Party's manifesto pledged to consider the case for making the information public on a multilateral basis while Labour, the SNP, the Liberal Democrats and the Green Party have all expressed their support.
